WELCOMING MESSAGE

The French Society for Vitamins and Biofactors (SFVB) and the Scientific Committee invite you to join the XVIe Fat Soluble Vitamins Congress. Started in 1960 in the UK then touring Europe every 4-5 years, the last XVe FSV has been held in Kalabaka (Greece, 2012) and was organized by Dr. Anargyros Moulas. The present Committees followed the general guidelines of these meetings to present participants with an overview of the most recent knowledge on diverse aspects of Fat Soluble Vitamins.

Since the discovery of these vitamins in the 1900s, many studies have been conducted to characterize their chemical structures, their metabolism and the mechanisms of their biological actions. Today, the on-going studies still investigate their potential beneficial role on metabolic disorders, underlying some worldwide spread diseases such as obesity and related diseases. The present meeting precisely plans update the most recent data in this respect, and it is hopefully expected to bring new perspectives and extension of the acquired knowledge. The final schedule of the meeting will be built when all the participants' contributions are sent to the scientific committee.

Papers on improved analytical aspects, on new findings on absorption and bioavailability, and on the use of high throughput technologies for an integrated view are all welcome. Data on the recent strategies to alleviate deficiency of fat soluble vitamins in developing and emerging countries are also welcome. Modern societies are nowadays interested not only in the nutritional value of foods but also in disease prevention and health promotion. Under this perspective epidemiological and clinical studies on the health effects of fat soluble vitamins and papers about functional foods with fat soluble compounds are expected. The meeting will also attempt to open the question on whether some other fat soluble biofactors can exhibit vitamin-like effects. Besides some expected works recently undertaken, this topic will be illustrated with lutein-zeaxanthin, as described through their specific accumulation in the macula and their relationships with age-related macular degeneration. This open-mind proposals aims at targeting the young scientists who are particularly wished and expected to participate. Help to participate in the meeting and attractive poster awards will be offered to them.

With your contribution, the Scientific Committee will set up an attractive scientific program that will allow to listen to outstanding international speakers. We are delighted to already welcome you in France and to discover the romantic Paris capital during the wonderful spring season.

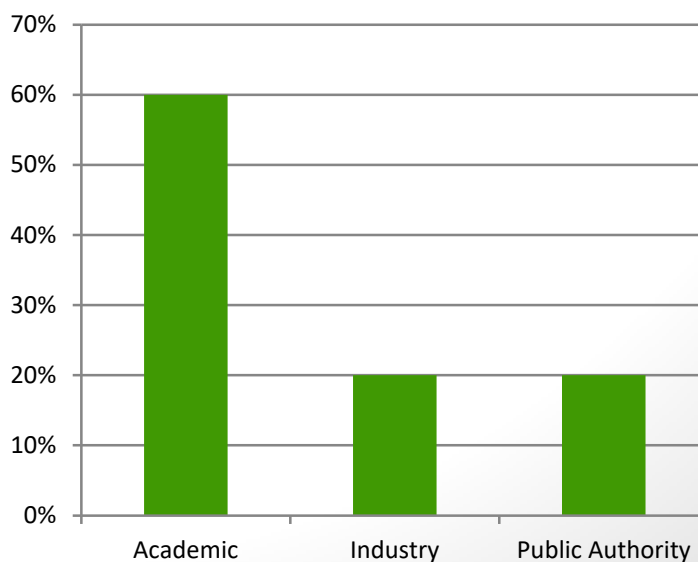

Rules and regulations

CODES AND REGULATIONS

Exhibitor hereby agrees to be bound by these « Rules and Regulations ». Exhibitor further agrees to adhere to and to be bound by 1) all applicable fire, utility, and building codes and regulations; 2) any and all rules or regulations of the facility where the 16th FSV is held ; 3) applicable terms of all leases and agreements between FSV/MO and the managers or owners of the facility ; 4) the terms of any and all leases and agreements between FSV/MO and any other party relating to the exhibit. Exhibitors shall not, nor permit others to do anything to the booth or do anything in the facility that will in any way increase the insurance premium payable by FSV/MO or the owners or managers of the facility.

DEMONSTRATIONS

All demonstrations and displays shall be confined to the booth. FSV/MO shall have the right to exclude or to require modification of any display or demonstration that, in its sole opinion, is considered unsuitable to or not in keeping with the character of the exhibition. FSV/MO shall have the right to prohibit the use of amplifying equipment or music that, in its sole discretion, is considered objectionable. FSV/MO shall have the right to demand modification of the appearance or dress of persons or mannequins used in connection with displays or demonstration.

ASSIGNMENT AND SUBLEASE

Exhibitor shall neither sublet the booth or any equipment provided by FSV/MO, nor shall the exhibitor assign its lease in whole or in part to any other party without prior written notice to and approval from FSV/MO.

Subletting or sharing of exhibit space is not allowed at any time. A participating exhibitor may not assist a non-participating representative in gaining access to the exhibit hall. (This includes public relations firms and other third party vendors). All signs, advertisements, publications, materials, products and representatives' badges must reflect the name of the contracted exhibiting company. Any violation of these regulations may result in an immediate shutdown and removal of the booth and materials in violation. Additionally, organizations found to be in violation of these regulations risk denial of participation in future meetings of the FSV/MO congress and removal from FSV/MO's approved exhibitors list.

LIABILITY

Exhibitor hereby agrees to and does indemnify, hold harmless and defend FSV/MO from and against any and all liability, responsibility, loss, damage, cost or expense of any kind whatsoever (including but not limited to cost, interest and attorney's fees) which FSV/MO may incur, suffer, be put to, pay or be required to pay, incident to or arising directly or indirectly from any intentional or negligent act or omission by exhibitor or any of its employees, servants or agents. Exhibitor further agrees that FSV/MO, and its respective agents and employees shall not be responsible in any way for 1) damage, loss or destruction of any property of exhibitor or 2) injury to exhibitor or its representatives, agents, employees, licensees or invitees. Under no circumstances will children be allowed in the exhibit hall during installation or dismantle. For the protection of your children and in order to maintain the scientific nature of the display, no children under the age of 18 (with the exception of infants carried in a body harness at all times) will be allowed in the exhibit hall during show hours.

CANCELLATION AND POSTPONEMENT OF EXPOSITION

In the event that the 16th FSV congress is postponed due to any occurrence not occasioned by the conduct of FSV/MO or exhibitor, whether such occurrence be an act of God or the common enemy or the result of terrorism, war, riot, civil commotion, sovereign conduct, or the act or conduct of any third party, then the performance of the parties of their respective meeting obligations shall be excused for such period of time as is reasonably necessary after such occurrence to remedy the effects thereof. If the occurrence results in cancellation of the FSV congress, the obligations of the parties under applicable agreements shall automatically be terminated and all booth payments shall be refunded to exhibitor, less a pro rata share of expenses actually incurred by FSV/MO in connection with the meeting.

PAYMENTS

A deposit of 50% of the total cost of the contribution requested must be sent with the order to be confirmed. FSV/MO will accept applications on a first-come, first-served basis until the exhibit space is sold out. Applications submitted without the required deposit will not be processed until a deposit is received. The date on which the deposit is received will be the date used when determining the order of the assignment of booth space. Balance of payment is due January 31, 2017. After January 31, 2017, the application and contract must be sent with full payment. If balance payment is not received by the due date, space reserved may be reassigned and the deposit forfeited.

Receipt of deposit does not guarantee assignment of booth space requested. FSV/MO reserves the right to reject any application for booth space.

Note that the organizations name listed on the exhibit application will be used in all Congress promotional material.

CANCELLATION/BOOTH REDUCTION

Organizations participating in the exhibition may cancel this agreement at any time by written notice to FSV/MO. The following schedule will be used when acknowledging the cancellation and/or booth reductions: booth reductions and/or cancellations received on or before December 31, 2016, will receive a refund of all fees paid less a 10% processing fee of total booth space reserved. Cancellations or booth reductions received from December 31, 2016 to February 28, 2017, provided full payment has been received, will receive a refund of 50% of the total amount due for booth space. No refunds will be made for cancellations or booth reductions received after February 28, 2017. FSV/MO reserves the right to resell any cancelled exhibit space without any notification to the cancelling party, or without refunding any fee paid by the exhibitor. If booth space is cancelled after February 28, 2017, the exhibitor will be responsible for paying the balance of the booth space, if one exists.

SECURITY

FSV/MO shall provide guard service throughout the hours of installation, show and dismantlement period, and exercise reasonable care for the protection of the exhibitor's material and display. Beyond this, FSV/MO, the show facility, or any officer or staff member or vendor thereof will not be responsible for the safety of the property or the exhibitor, his agents or employees, from theft, damage by fire, accident, or any other cause. Exhibitor is required to secure sufficient insurance coverage for all booth contents.

Rules and regulations

POSSIBLE ADDITIONAL EXPENSES

All furniture, accessories, electrical requirements, booth carpeting, and booth cleaning are the responsibility of the exhibitor. All measurements shown on the floor plan are approximate, and FSV/MO reserves the right to make such modifications as may be deemed necessary, making equitable adjustment with any exhibitor or exhibitors thereby affected. FSV/MO also reserves the right to adjust the floor plan to meet the needs of the exhibition.

NO SHOWS

Exhibiting companies that reserve exhibit space and do not provide FSV/MO with written notice of their inability to exhibit before the first installation day will automatically be charged a lounge fee of 1.000 € and will forfeit all payments for booth rental.

OFFICIAL EXHIBITS

All exhibits must be assigned by FSV/MO and will be located in the designed exhibition area(s). No organisation or their representative may display, demonstrate, or distribute products and/or services in any location other than the designated exhibit display area. Displaying promotional advertisements, the distribution of printed materials, as well as the solicitation of orders outside of your contracted exhibit, is strictly prohibited. These rules apply to all organisations in attendance at the 16th FSV congress. Exhibitors who have been approved to host an exhibitor-sponsored event or who are participating in the « Doctor's bag » programme or other FSV marketing programmes may only use these marketing vehicles to promote their products/services which have been approved for exhibition by FSV/MO.

NON-EXHIBITING COMPANIES

Non exhibiting companies and their personnel, agents and contractors will not be permitted in the exhibit hall at any time. In addition, non-exhibiting companies will not be allowed to display or demonstrate any services or products in the convention centre or any hotel within the FSV housing block.

PRODUCT/SERVICE DISPLAYS

The exhibitor is permitted to demonstrate devices, instruments, equipment, or services, to make presentations and to distribute printed materials related to those products or services that FSV deems appropriate. Please be aware that only those products or services that are related to the congress are permitted. FSV/MO reserves the right to decide the appropriateness of any service, product, device, videotape or audiotape.

SELLING

To help companies to maximize the exhibiting opportunity, exhibitors will be allowed to sell products/services in the exhibition hall. The exchange of checks and credit cards for a product or service is allowed. Every transaction must be accompanied by a receipt for the purchaser. It is the exhibitor's responsibility to acquire any necessary licenses, permits, and/or identification numbers required by the local government to sell products/services.

SPACE ASSIGNMENTS

Booth assignments will be made based on the date received and the amount of space purchased.

HANDLING AND STORAGE

FSV/MO and the owners or managers of the facility where the FSV congress is to be held shall not accept or store display material or empty crates, and exhibitor shall make its own arrangements of shipment, delivery, receipt and storage of such material and empty crates. All shipments and deliveries to the FSV congress shall be prepaid. Exhibitor shall not incur any obligation to the FSV congress merely by reason of providing copies of any bills of lading hereunder.

EQUIPMENT

Booth equipment provided by FSV/MO and/or its vendors or agents shall be returned to FSV/MO vendors or agents at the end of the meeting complete and in good condition, normal wear and tear expected. Exhibitor shall have no right, title or interest in such equipment. Exhibitor shall provide all other equipment at his or her own expense. All draping and decorative materials used by exhibitor shall be flameproof.

INSURANCE

It is the responsibility of each exhibitor to maintain insurance against injury, property damage, theft, fire and any other forms of property loss or injury. FSV/MO requires that all exhibitors maintain insurance in the amount of 1.000.000 € or whatever amount is specified by local governments, for general liability insurance and workers compensation.
